respect of 5 nervous shock claims brought by a family against an insured real estate agent. The agent had managed a property which was burnt down when the 12 year old autistic resident, playing with matches early in the morning prior to her parents awakening, had inadvertently started a fire by dropping the burning matches on her synthetic blanket and setting herself on fire. The child had suffered terribly and had died from the horrific injuries in hospital a month after the fire. The mother had personally re-entered the burning house after the father exited the house after being overwhelmed by the heat and dragged her daughter to safety. The family alleged that the agent had been negligent by failing to ensure that the smoke alarms were functioning. The agent in turn was upset that he had rented a perfectly good home to the family, and they had caused it to be burned down. Laina worked hard to get both sides to see the other's point of view and to clear the misunderstandings that had arisen between them. An added complication was that the insured real estate agent was potentially underinsured.

Not only did Laina manage to achieve a negotiated outcome within the limit of indemnity at mediation, but she also managed to get the parents and the agent to have a frank and open discussion with each other in circumstances where the mother had initially turned her back on the agent and refused to speak to him. Her suggestion had been met by resistance by the legal representatives for the family, but Laina used her learning in collaboration and reflective listening to enable a meaningful meeting between the legal representatives and the parents. The agent apologized to the parents and the parents expressed their anger at the agent. By the end of a very emotional meeting lasting half an hour, the parents, including the mother found her way to expressed forgiveness to the agent who was obviously personally distraught about the circumstances of the claim. He had previously expressed that he had not slept properly in almost 2 years. At the end of the mediation, the parents were content with the outcome and left the mediation on good terms with the agent, the insurers and the entire legal team which assisted with enabling closure for everyone. This was such a marked change from the beginning of the mediation when the mother had turned her back on the agent and had refused to acknowledge him.

Laina has a sound grasp of the law

I have found Laina to be extremely knowledgeable on the subject of the law and she is widely published in Insurance, Construction, Property and Arbitration. She was able to utilize her knowledge of Insurance, Construction and Arbitration Law last year when she acted for us in a series of complex cases in Western Australia. Her devised strategy to address the complexities of the case, caused by the fact that the insured was bound by an arbitration agreement in the design and construct contract that it had with a Head Contractor led to a successful outcome for our insured and a costs order in their favour.

By way of background, the insured had retained an engineer to fulfil the design component of its post tensioning sub-contract with the Head Contractor. However, the insured had not included an arbitration agreement in its sub-contract with the engineer. When it emerged that the engineer had been negligent in the preparation of the design and its design had caused the cracking in the roof slab, the insurers of the Head Contractor had commenced subrogated recovery proceedings by way of arbitration against the insured to recover the amounts spent on the rectification. The total claim

was in excess of \$6 million. The insured sought to join the engineer to the arbitration. In the absence of an arbitration agreement between the insured and the engineer, this course was met with resistance by all concerned including the arbitrator. Laina used her legal and technical ability in respect of arbitration law and her knowledge of the *Commercial Arbitration Act 2012* (WA) to navigate these issues. Further, an issue arose as to whether the insurers had waived their rights of subrogation against the insured. These issues were ventilated over a 6-month period including applications to the arbitrator and the Supreme Court as well as attendances at several informal settlement conferences with the Head Contractor. Laina successfully negotiated an outcome that was well within the reserves that Berkley Insurance had set for the matter but also represented an excellent outcome for the insured for which they were most appreciative.

Laina is widely published and gives back to the profession

There can be no doubt that Laina has immersed herself in the law and has been lucky to have learned from great and talented minds such as Kirby JA and Professor J W Carter. Laina's publications on the interplay between insurance and construction law, the enforcement of extended contractual warranties and alternative dispute resolution are used nationally and internationally. Further, she has lectured on Masters Programs on Construction and Contracts Law at both the University of Melbourne and the University of Sydney. It is a tribute to her that her textbook with Professor J W Carter on Contract and the Australian Consumer Law is a recommended textbook for the Torts and Contracts course at the University of Sydney. Her work with Professor J W Carter on the restitution is also on the reading list for remedies for the Masters of Construction Law at the University of Melbourne. She is currently an instructor for the New South Wales Bar Reading Course, volunteers for the New South Wales Bar Pro Bono Scheme and always puts her hand up to mentor three to four mentees a year.

I have had the privilege of meeting a couple of Laina's mentees who have spoken very highly about their time with her and the teachings that would remain with them forever. Laina comes from a very learned family all of whom understand the importance of encouraging and nurturing up and coming talents which has ensured that Laina is like minded and willingly gives unselfishly her time to those that she is mentoring.

It is rare to find such a humble super talent but I can say without equivocation that Laina is that person. I believe that her contribution to the law ought to be recognised as a stand out talent and it is for this reason I highly recommend that she be awarded the accolade of Barrister of the Year .

During FY21-22, Laina has provided valuable pro bono assistance in four different matters, two of which are complex proceedings before the Supreme Court and Court of Appeal.

It is particularly noteworthy that Laina has secured favourable outcomes for her pro bono clients in *Aslan v Stepanoski* [2022] NSWCA 24 and in *Goyal v West* [2021] NSWSC 526. Both matters involving unconscionable conduct and significant financial loss for the litgants.

Our clients frequently experience vulnerabilities including disability, under-employment or mental health concerns. The clients are not always capable of providing clear instructions or a coherent picture of the desired outcome. Laina has responded to these challenges by approaching all of her clients with empathy, respect and patience.

Laina's assistance in these matters has also worked to strengthen the relationship between the Courts and with members of the bar. Most applicants referred by the Courts are not eligible for assistance from Legal Aid NSW, nor are many Applicants able to afford representation. Through the participation of barristers in this pro-bono scheme, the Court is able to directly refer applicants that are in need of Assistance to members of the Bar who are willing to volunteer their time and expertise.

I wish to commend Laina for her ongoing commitment to access to justice and pro bono.
